

## SARATOGA PLAN IS YOUR LOCAL LAND TRUST





A land trust is a nonprofit organization that protects land with natural, recreational, scenic, historical, or agricultural value.

Land trusts work within their communities to ensure benefits from these lands last for future generations by acquiring land outright or holding conservation easements (permanent agreements that limit land use to protect its resources).

## Land trusts can help:

- Protect air and water quality
- Conserve habitats for wildlife and plants
- Connect people to nature through free public access to local trails and preserves
- Protect family farms and ensure agricultural land remains accessible for future farmers
- Make communities more resilient to the effects of climate change
- And so much more!

Land trusts are flexible and community-driven, working with landowners, local municipalities, non-profits, trail user groups and other partners. There are over 460 accredited\* land trusts across the U.S.

Saratoga PLAN is the only land trust focused on protecting land in communities in and around Saratoga County.



\*Accredited land trusts have demonstrated fiscal accountability, strong organizational leadership, sound transactions and lasting stewardship of the lands they conserve.

Saratoga PLAN acquired Snake Hill in December of '23, ensuring the iconic landmark would never be developed. Since then, we have been working to protect the highly cherished and valued hemlock trees and heard from over 170 community members who shared their thoughts on the future of Snake Hill.

## Here's what we heard from you:

## You care deeply about Saratoga Lake.

Many of you have spent decades on or around Saratoga Lake, and you have extensive knowledge about who spends time at the lake and what they do there. You recognize the importance of Snake Hill and its role as a visual, historic, and natural resource in your community.

Many of you want to make sure that you, your neighbors, and your community have safe means of access, parking, and enjoying Snake Hill. Many of you have a strong desire to visit Snake Hill or hope that others can visit to share in what makes this place so special.

Many of you appreciate the unique environment of Snake Hill, and you care about preserving it and learning about it. Most community members who shared their thoughts advocated for limited or no public access. Some of you are learning about Snake Hill and why its preservation is important.

## What's next for Snake Hill?

- PLAN team members are reviewing your comments carefully, and your feedback is guiding revisions to our management approach.
- Our staff continues to learn about Snake Hill history, resources, and values through research and onsite activities. We will continue to share what we learn with you.
- We are sharing feedback with local community & municipal leaders, and asking them for ideas as well.
- At the end of 2024 Saratoga PLAN will finalize the management plan for Snake Hill.
- Informed by your feedback, we will host an online public meeting in early 2025 to share more details about our management approach and answer your questions.

# LOCAL CONSERVATION PROJECTS MOVE FORWARD





**WE ARE THRILLED** to share that PLAN has been awarded funding for two farmland protection projects from NYS Department of Agriculture & Markets as part of New York's Farmland Protection Implementation Grants program!

The local farms that will benefit from this funding include Egan Farm and Stem & Stone Farm in the Town of Ballston.

**WE ARE PLEASED TO ANNOUNCE** that PLAN has also been awarded funding for three conservation projects from the Saratoga County Farmland Protection and Open Space Grant program!

Projects include a 47-acre horse farm, 75 acres of agricultural land, and 81 acres of land with high upland habitat within the Southern Palmertown Range.
