FARMLAND CONSERVATION PROGRAM UPDATE

BUDS AND BLOSSOMS AREN'T THE ONLY THINGS GROWING THIS TIME OF YEAR. Saratoga PLAN's farmland conservation program is, too. Since December, PLAN has been awarded five Farmland Protection Implementation Grants (FPIG) from the New York State Department of Agriculture and Markets (NYSDAM).

PLAN will use these grants to purchase the development rights on **613 ACRES** of productive farmland. Retiring development rights is how PLAN keeps land permanently available for agriculture, natural habitat, and recreation. PLAN also assisted the Town of Clifton Park in securing a grant to protect **72 ACRES**.

In addition, PLAN received a grant from NYSDAM to pay for appraisals on **10** proposed farmland protection projects totaling **1,060 ACRES**. Once landowners know the fair market value of development rights, they can make an informed decision regarding protection of their farmland.

The success of these projects is rooted in PLAN's agricultural outreach efforts, as well as funding from the generous donations of our supporters and business partners, as well as grants from the Hudson Valley Farmlink Network* and the State of New York.

In 2017, Lorna Kircher made the largest charitable donation she has ever made in her life to Saratoga PLAN. “Frankly, I stunned myself by making such a large contribution, but it was the smartest thing to do, and it saved me money.” She found the same benefit again in 2018, especially with the new federal tax laws.

One of the driving forces behind her donations was that after age 70½, the IRS mandates an annual Required Minimum Distribution from tax de-

ferred retirement investments. The required distribution from IRAs can jettison thousands of dollars into taxable ordinary income. “My goal now is to prevent my Required Minimum Distribution from increasing my overall taxable income and jumping

me into a higher tax bracket, increasing my income tax burden and Medicare cost,” said Lorna.

Working with her financial advisor, Lorna found that the benefits of a charitable donation can be recaptured by making a Qualified Charitable Distribution. Lorna says, “It is a wonderful tool for lowering your taxable income and managing your tax bracket while allowing you to donate to the organizations you want to support.”

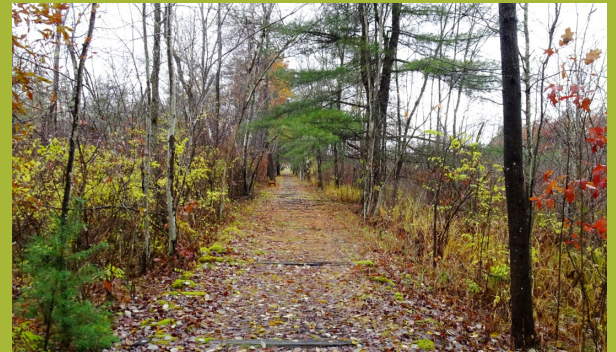
For people in Lorna’s age group who want to underwrite the important goal of land conservation, she strongly suggests that they look at what their new tax bracket is and whether making a Qualified Charitable Distribution to Saratoga PLAN would save money otherwise paid in taxes, allowing them to continue to support “this wonderfully effective organization.”

BARBER BROS. DAIRY (PHASE I)



Town of Northumberland: 464 acres of cropland that supports the dairy herd of approximately 1600 cows. This is PLAN’s largest ever farmland protection project.

MEADOWBROOK PRESERVE



City of Saratoga Springs: Bog Meadow Brook traverses 75 acres of woods and wetlands that will expand our Meadowbrook Preserve to 265 acres and will act as a critical link in the city’s Saratoga Greenbelt Trail.
