

Farmland Conservation

174 ACRES OF FOREVER FARMLAND

This April, we helped the Hanehan family to conserve 174 acres of the Hanehan Family Dairy in the Town of Saratoga. The farm's productive soils grow feed and pasture cows and calves, and its woodlands and wetlands serve as wildlife habitat. The farmland itself acts as an excellent rainwater capture system, replenishing groundwater and preventing flooding. Additionally, by conserving their farmland, the Hanehans are not only helping to ensure access to our local food supply but are also keeping the rural scenery of Saratoga intact.

Funding to protect this farmland came from the Dairy Transitions Farmland Protection Initiative administered by the NYS Department of Agriculture and Markets.

NATIVE WILDFLOWERS BLOOMING AT GLOWEGEE CREEK SOUTH TRAILHEAD



Earlier this year, on Earth Day, the Galway Lions Club and Capital Mohawk PRISM partnered with PLAN volunteers to restore the trailhead at the newly opened Glowegee Creek Trail South in the

Town of Galway. Together we seeded a 5,000 square foot space with native wildflowers and removed invasive multiflora rose and honeysuckle from the perimeter to prevent them from creeping into the field. Saratoga PLAN volunteers later planted native trees and shrubs along the border of the meadow to further increase local vegetation and support native pollinators. We look forward to watching the meadow bloom in the years to come. We are so thankful to all



volunteers and community partners for bringing this project to fruition.

BARKERSVILLE TRAILS



From a fern-carpeted forest floor to birds singing in the trees, this lush, wooded landscape is full of life. Adventure awaits you on the 2.5 miles of winding trails open to the public. ALDRICH COMMUNITY FOREST

With plans to incorporate trails for active recreation as part of the larger Sarah B. Foulke Friendship Trail system, this viridescent 145 acres in the Town of Greenfield is every outdoor enthusiast's dream. To date, we've raised 30% of the



\$88,000 needed to protect this forest with a conservation easement for the future. Help us get closer to forever. (Please make a note that your donation is for the Aldrich Community Forest).

COUNTY COMMUNITY FOREST



Saratoga PLAN, the Open Space Institute, and the towns of Wilton and Greenfield are assisting Saratoga County with the purchase of over 200 acres of the Palmertown Range for a community-managed county forest, with important woodlands, streams,

and historic sites, as well as future hiking and mountain biking trails. The project has already been awarded \$391,000 from the U.S. Department of Agriculture's (USDA's) Community Forest Program; we now need to raise private funds to secure this important community resource.
