

## land conservation

WE ARE PLEASED TO ANNOUNCE that PLAN has secured a \$301,497 grant for a conservation easement on a 435-acre forested property in Greenfield and Wilton. This property is an integral piece of the expansive Palmertown Range within the Southern Adirondack Foothills, which spans 40,000 acres in Saratoga County.

The Land Trust Alliance administers the Forest Conservation Easements for Land Trust (FCELT) grant program in coordination with New York State Department of Environmental Conservation (DEC).

This forest supports carbon storage and sequestration, aligning with climate change mitigation efforts. The property's diverse ecology and sustainable forest management will contribute to the long-term resilience and well-being of the community.
